Note: No late admission is allowed under Semester System. Moreover, no supplementary case shall be accepted under Semester System. Registration Return must be submitted by due date otherwise it shall not be entertained.

UNIVERSITY DUES / SHARES

- i) Registration dues / University share shall be deposited for **B.Ed 1.5 (General, Science & ELT) programs** as per detail given below:-

NOTE: All the Affiliated Colleges must ensure the provision of deposit slips / bank challans of all University dues / University shares at the time of submission of Registration Return. Otherwise Registration Return will not be accepted. Please use separate bank challan form for each programs.

TERMS & CONDITIONS:-

- i. The University dues must be deposited in any branch of Habib Bank Limited University of Sargodha Account **No.00427991796303**, on computer generated bank challan voucher. The challan form can be downloaded from University website www.uos.edu.pk Demand Draft, Banker's cheque and hand written bank challan etc. will not be acceptable. The challan form must bear the detail of discipline and break up of fee.

- ii. All Affiliated Colleges / Institutions of UOS etc. should submit Registration Return, discipline wise, alongwith its enclosures (Annexure A, B & C), complete in all respects with in due date. Incomplete Registration Return / without its enclosures will not be accepted and returned to the quarter concerned forthwith. Further, the quarter concerned will be responsible for any loss that may occur to the students. The Registration Return alongwith its enclosures can be downloaded from University website www.uos.edu.pk.
- iii. After the expiry of the Admission Schedule, Registration Return from any of the Affiliated Colleges shall not be accepted. However, in special cases considering the genuineness of delay after the last admission date, Registration Return may be accepted with actual dues + special fine of Rs.5000/- per student provided that at least 45-days are left for the terminal examination.
- iv. Excess amount of one academic session shall not be carried forward to next session.
- v. In case of struck off / dropout / left over students of Affiliated Colleges, the college management is bound to submit a list of such students duly verified by the Controller of Examinations, University of Sargodha to Registration Branch within 15 days from the last date of submission of Registration Return, University share of such students may be waived off only.
- vi. The discrepancies, if any, will be communicated the Affiliated Colleges must remove mentioned discrepancies within 15 days of receipt of the letter.
- vii. No admission can be withdrawn or transfer to another discipline once the Registration Return is submitted to the University.
- viii. All the Affiliated Colleges (Govt. / Private) are requested to provide the N.O.C from the relevant Council.

6. ELIGIBILITY

The eligibility of students shall be determined for each discipline as per eligibility criteria of the University.



- i. The eligibility of students shall be determined for each disciplines as under:

Sr. No.	Name of program	Eligibility criteria
01	B.Ed 1.5 (General)	16 Years of Education (Academic Disciplines other than Education) with Minimum Second Division.
02	B.Ed 1.5 (Science)	16 Years of Education (Academic Disciplines other than Education) with Minimum Second Division.
03	B.Ed 1.5 (ELT)	16 Years of Education; MA / BS English in Minimum Second Division (In Annual System) or Minimum CGPA 2.00(In Semester System)

- ii. Admission of candidates with compartments and supplementary exam in the same academic year is not allowed.
- iii. In case of AIOU students only those students will be eligible to get admission for session 2024-25 (Fall 2024) who have completed their previous degree by Fall 2023 or earlier.
- iv. All documents (Notification by Affiliation Branch, CNIC, last Result Card / Transcript / NOC and Registration Form) must be submitted along with Registration Return. No student shall be issued Registration number provisionally.
- v. Due care should be taken while making admissions and reporting them in Registration Return from Eligibility point of view. The deposited dues of the ineligible students shall not be refunded.

7. The Principals / Directors of Affiliated Colleges / Institutes are requested to follow the above mentioned Admission Schedule / Terms & Conditions / Eligibility Criteria / Fee detail in letter and spirit.
