- Bidding documents in proper sealed envelope will be received in the Office of Project Director (Works), University of Sargodha Main Campus by 03:00 P.M on October 13, 2020 (Tuesday) and will be opened by the procurement Committee in the presence of contesting contractors or their authorized representative, at 3:30 P.M the same day at the office of Project Director ( Works) at Main Campus University of Sargodha.
- All the Firms / Contractors will be bound for strict compliance of all terms and conditions issued by Govt. and University of Sargodha Authorities from time to time.
- Valid PEC license, NTN and other required/relevant documents are to be produced before issuance of tender document.
- Connivance / negotiations during process are strictly prohibited. If any contractor / firm found involved in such practice, tender will be cancelled.
